All caterers must provide a Certificate of Insurance (COI) showing the Contracting Party has in force bodily injury and property damage liability in the amount of no less than \$1million combined single limit, also to include Workmen's Compensation. The COI shall state the additional insured as Port Annapolis Marina (PAM), 7074 Bembe Beach Road, Annapolis, MD 21403. If any alcoholic beverages are to be served, caterer must submit a Liquor Liability Certificate of Insurance to "PAM", Forty Five (45) days prior to the event and a copy of their "TIPS or TAM Certification for the person attending the bar. If you don't carry a Liquor Liability Certificate, please inform the event prior, so they may obtain a "Host".
